Call for Tenders relating to airspace design, capacity planning and Demand Data Repository

Its overarching mission is to contribute to the delivery of air traffic management's (ATM) performance in the pan-European network in the areas of safety, capacity, environment, flight efficiency and cost effectiveness. So as to properly fulfil its role, the Network Manager brings together the different aviation air traffic management actors involved in the design, planning and management of the European ATM network.

One of the Network Manager's tasks is to develop, maintain and implement the Network Strategy Plan (NSP), which is the strategic tool for managing the European ATM network and which is aligned with the ATM Master Plan. The NSP defines the strategic operational objectives needed to achieve the required levels of ATM performance and serves as a reference for the activities to be carried out by the Network Manager (NM) and its operational stakeholders. The Strategic Objectives S03 and S04 address respectively the implementation of a seamless and flexible airspace and the planning of optimum capacity and flight efficiency. The Network Strategy Plan includes a number of Network Strategic Projects amongst which the Free Route Airspace Strategic Project. The work in this task is in support of the Network Management Function European Route Network Design, the Free Route Airspace Network Strategic Project and the associated PCP functionalities.
